1)HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE

the promoted, participants, rodeo association, sanctioning organization or any subdivision thereof, arena operator, arena owner, officials or any persons in any restricted area, promoters sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officials or any persons in any restricted area, promoters, sponsors, advertisers, owner and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands thereof on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases of otherwise while undersigned is in or upon the restricted area, and/or competing, officiating in, observing, working for, or for any purpose participating in the event.

2)HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the releases

and each of them from any loss, liability, damage, or cost they may incur due to the presence of the undersigned in or upon restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the event and whether caused by negligence of the releases or otherwise.

3)HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE due to the negligence of releases or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the event.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of the event are very dangerous and involve risk of serious injury and/or death and /or property damage.

EACH OF THE UNDERSIGNED

further expressly agrees that the foregoing release waiver and indemnity agreement is intended to be as broad and inclusive as is permitted y the law of the Province or State in which the event is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, not withstanding continue in full legal force and effect.
